# AN OVERVIEW Clinical Note Taking and Ethical Considerations

Clinical note taking is an important and required aspect of a psychologist's work. Whether you are an experienced professional or new to the field of psychology, there is one common feature that many psychologists report to being unsure which is how to write and/or structure their case notes.

This workshop will present information that is available from the APS, AHPRA and other reliable sources on how to write and structure case notes. It will also address ethical and legal requirements that need to be considered when writing, storing, and sharing case notes.

A critical aspect of clinical note taking, including intake and consent forms, is to ensure that intake forms and case notes are relevant to specific work roles and organisational requirements. The workshop will be limited in numbers so that individual care and guidance can be given towards this critical area.
